Mr Poulie, tell us a little bit about your background and how Theodora Foundation was found.

I was born in Amsterdam. I lived in Blaricum (Holland) where I did my first steps exploring the world. I arrived in Switzerland with my parents and my brother at the age of three. I went to public school until I was ten, I was then sent to "Le Rosey" an international boarding school based in Rolle. As a child I travelled a lot with my parents and they made sure I learned to respect to all cultures and beliefs. My parents transmitted to me their old school values of commitment, hard work, dedication to community and others. I lost both my parents from cancer and after my mother died, my brother and I wanted to do something to honour their memory. One of the main things that I learned from them, that is beautifully expressed in the quote of Antoine de Saint Exupery: "It is only with the heart that one can see rightly; what is essential is invisible to the eye."

It is with this in mind that we founded the Theodora Foundation in 1993 in memory of our parents and we named it after our mother "Theodora". When my brother was hospitalized for many months as a child, Theodora brought joy, laughter and storytelling to his bedside through her regular visits. Theodora inspired us to bring magical moments to all sick and disabled children. To date, the lives of over two and a half million children have been improved worldwide thanks to regular visits of our Giggle Doctors.

Over the years Theodora has become a recognized leader in its field and has been awarded numerous recognitions for the quality of its mission. In

Switzerland Theodora was awarded the "Adele Duttweiler" and "Doron" prizes, in the UK Theodora received the prestigious Guardian Charity Award in 2003, which honours outstanding charities. Theodora has always been a pioneer in bringing new ways to help children and their families cope with the difficulties of hospitalisation. In Spain Theodora received from the Ministry of Health of Cataluña, the price for the best initiative that **enhanced the wellbeing** of the children and their families while hospitalised.

What is the mission of the Theodora Foundation?

At the Theodora Foundation, we believe that laughter and play are the best medicine, therefore in accordance to our mission statement: *«For the children in hospitals and institutions we have at heart to contribute to their wellbeing by offering visits from professional artists trained to work in a medical environment. »*

Since its beginnings in 1993, the Theodora Foundation has pursued its mission; to bring laughter and joy to children in hospitals. Today, the Foundation organises and funds the weekly visits of professional artists – the Giggle Doctors. Today our team of 206 "Giggle Doctors" visit over 250'000 children each year in 150 hospitals, hospices and specialist care centres across 8 countries. By combining music, play, magic and storytelling, these professional performers bring magical moments to children and their families facing some of the most challenging times of their lives.

Theodora has been active in Turkey since October 1998. Today our programme has expanded – in 8 hospitals and 1 specialist care centre for children with disabilities. During 2015, our 12 Turkish "Sevgi Doktorları" (Giggle Doctors) spread smiles and moments of happiness to more than 25.000 children.

What is a "Giggle Doctor"?

Our Giggle Doctors are professional performers, highly trained to work both in the medical environment and with children with disabilities. They come from a wide range of backgrounds and bring with them a variety of skills (among our team are actors, entertainers, magicians, musicians and singers). The training consists of a rigorous schedule of artistic and medical workshops that cover topics such as child development, infection control, child bereavement and the impact of illness and bereavement on families.

They are trained in "Intensive Interaction" which is a practical approach to working with people with very severe learning difficulties, helping them to relate and communicate better with the people around them. The Giggle Doctors learn the fundamentals of communication, exploring the elements that come into play: position, movement, mirroring, repetition, eye-contact and most of all having fun and providing opportunities for play.

When did you decide to come to Turkey and why?

In fall 1997, I came to Turkey to visit a dear friend of mine. During my visit Dina Topbaş Şakir said to me: "You know it would be wonderful to bring the Theodora's Giggle Doctors to Turkey" and added she would help if we did. So I started looking for funding and support for this new project.

In April 1998, we received financial support from 3M Healthcare where I met two wonderful ladies. So with the dedicated and exceptional support of Dina Topbaş Şakir, Zeynep Sungu and Mirey Nasi, we started our first visits at the "Children's Clinic of the CERRAHPAŞA Hospital" on the 15th of October 1998. Since then we have visited over 300'000 children in Turkey and the program has grown to what it is today. Turkey was one of the first countries in the world to have "Sevgi Doktorları" visiting hospitalized children.

Are there any upcoming projects in Turkey?

We have received repetitive requests from Hacettepe Hospital in Ankara for an increase in the number of visits of our "Sevgi Doktorları". There is certainly a need for us to visit the departments that we cannot cover at the moment. So this is one of our primary projects that we would like to establish with the support of prospective donations. In line with our objectives for Theodora Turkey we continue to look for opportunities to visit more children in different cities. In this scope for the second half of 2016 we are aiming to start with a new hospital in Eskişehir with the valuable contribution of a current supporter of Theodora Turkey. The next scheduled project is to collaborate with a potential partner from Switzerland to launch the visits of Sevgi Doktorları to a new hospital in İzmir. With this we will be active in four major cities of the country. It is of the outmost importance to maintain our "Swiss Quality" while we are growing. Hence we will also look for the possibility of enlarging our team with local artists in the planned cities. This will certainly require the hiring and training of new "Sevgi Doktorları". But this will only be possible with additional corporate social responsibility projects and financial support of Turkish donors.

What kind of donations can be made?

In order to sustain and expand all these projects we need financial support. Alongside private and corporate donations, we encourage people to start activities to raise funds for the children in hospital, such as charity concerts, sport events, employee initiatives etc.. Moreover, we are available as a trustworthy partner for companies that are interested in local, long-term or short-term "Corporate Social Responsibility" projects, helping them to get into the public eye. If you consider becoming a partner with us we can work collaboratively in order to support hospitalized children in Turkey.



What role does the Chamber of Commerce play in your business life?

We have been a long time member of Swiss Chamber of Commerce.

Being a member firstly facilitates extensive and qualified networking possibilities. It also creates an opportunity to exchange information on best practices.

Furthermore we have found a synergy with the energetic team of the Swiss Chamber of Commerce, which has led us to develop different projects for fundraising, including the Christmas Charity Cocktail on December 2015. These events have not only been fruitful in terms of fundraising but also have created for us an environment to communicate our projects.

We look forward to develop these fruitful relationships in order to bring joy and happiness to even more suffering children. Looking back to all the smiles we have brought with the help of our generous donors and partners, the wise words of Winston Churchill come to my mind: "We make a living by what we get, but we make a life by what we give."

Swiss Alumni Interview Gözde Ünal, Lawyer

How come you went to Switzerland?

After my graduation from IEL which offers the best education accepting only the very chosen students and which is also one of the best and rooted of the education system in my country, I had the chance to be educated in Germany, Austria, Switzerland Universities with my diploma.

It was my great ambition to study in a modern, multicultural country, which we have adapted our law system.

During which time period have you gone to university in Switzerland?

I went to the Faculty of Law at the University of Zürich during the years 2003 and 2009.

Do you have any special memories?

I was working in a part time job in the opera of Zürich and it was a very special moment for me to meet worldwide famous Tina Turner.

Studying in Switzerland is a multicultural experience since you have students and teachers from all parts of Switzerland speaking German, French and Italian. I had mastered Swiss German in six months time.

I studied one semester at the canton ST. GALLEN and had the experience to learn in small classes and with the best grades at the exams, whereas people who were born and grew up in that country could not succeed in.

I had two seminars in the years 2007 and 2008; one in Parma (Seminar: Parmaschinken und Parmesan) and the other in a castle in Kanton ZÜRİCH (mediation and other dispute resolution) I gained experience by making presentations and had good grades.

SWISS ALUMNI

Please give us a brief insight on your personal experiences during that time?

This experience improved and enriched my personality.

What is so special about Swiss education? What do you appreciate most having studied in Switzerland?

What I took as an example and admired most was that the education system was not memory based (which was just the opposite in Turkey) and the cases were analytically solution oriented and even during the exams the solutions were reached by searching the laws.


Furthermore, what I personally witnessed was that the education system was a lifelong process and not only university oriented but by the means of trading schools...This I could also see that the students were not in a racing media but socially improving themselves by their personal activities, and thus improving their personal characteristics and abilities .As a result I summoned up that the education system of an country is directly proportional with the development of that country.

What would you recommend Turkish parents who want to send their children to a Swiss school?

Switzerland claims to have one of the world's best education systems approved by several institutions. My recommendation would be to the parents who want to send their children to Switzerland, that their child has a certain base of the languages spoken in Switzerland (especially Swiss German) to be able to build on that.

On the other hand the students should have the ability of learning by themselves in developing and improving themselves.


"A Change of scenery, Swiss Film Festival at Istanbul Modern


Yolda – on the move between Switzerland and Turkey

When robots look like people

When it comes to innovation, Switzerland is at the top of the league. Time and again Swiss spin-offs grab attention with spectacular ideas. And most of them work in the area of information technology.

The company Insightness is one of 315 spin-offs founded over the past 40 years at the ETH Zurich. It has developed a sensor that lets cameras work in a way that is similar to the human eye. This could provide access to a billion dollar market and also solve a problem that Google failed miserably with two years ago.

Christian Brändli, co-founder of Insightness, reported on this groundbreaking idea in an article in the newspaper 'der Bund': "Human vision stands out first and foremost due to the fact that it reduces the quantity of data to a minimum. An example of this is a car travelling towards us. The street is merely the background, and what is driving towards us doesn't really interest us either, only where it is." The objective is thus to ensure the camera can perceive the position of objects in real-time at all times. And this is exactly what the Silicon Eye Sensor does. Thanks to intelligent pixels, it only records the changes in the field of view and thus avoids redundancy in those areas where nothing changes. The sensor could be relevant for many modern applications – just like the Google Glass, the viewer could wear intelligent glasses and then perceive his/her surroundings more intensively through virtual objects such as labels.

The potential of the company and its vision are very promising. As a result of this, the Swiss Government has now also provided a large sum of money and added its name to the long list of sponsors, which already includes the renowned Gebert-Rüf-Stiftung.

The company Insightness is just one of many success stories, which will be written in the future in Switzerland. According to the Global Entrepreneurship Network, GEN for short, an index for the best startups in the world, Switzerland moved up from position nine to eight in 2015.


