Editorial

Dear Readers,

As the Honorary Consul of Switzerland in İzmir, I am delighted to have the opportunity to write the opening words for this issue of the Newsletter of the Swiss Chamber of Commerce in Turkey. It is especially refreshing to report from İzmir for the July edition, as the Summer promises peak activity for tourism and travel in our region.

One of my important responsibilities as Honorary Consul is the promotion of cultural and commercial exchange between Switzerland and Turkey. I am fortunate this to carry responsibility in a location such as İzmir. the city and its as surrounding region offer such a wide spectrum of choices for culture, as well as for trade and investment.

For centuries, İzmir has been a prominent port in the Mediterranean, and acted as a natural home to tradespeople and trading companies. The port handles almost 20% of the country's foreign trade, embracing merchandise from all over the world, and acting as gateway for Turkish products to be sold globally. The Aegean region is the source of many traditional Turkish export products, including the world famous agricultural produce. At the same time, the region hosts

some of the country's most important investments in steel, textile, electronics, food products, agribusiness and many other industries.

The traditional businesses complement the modern outlook of our city's economic potential in progressive industries and research and development. Two of the country's leading teaching (university) hospitals are located here, alongside many private and state institutions offering comprehensive medical treatment. Izmir supports the theme "Health for All" and is welcoming investment the pharmaceutical in and biomedical industries as well as facilitating research and development in these fields. The Swiss Chamber of Commerce in Turkey, together with the Swiss Business Hub Turkey, supports the development of research centres and is in cooperation with the universities to organize bilateral workshops and conferences.

More than 1.4 million foreign nationals landed in İzmir in 2013. The new domestic terminal of the Adnan Menderes Airport opened in March, 2014, and promises to be the second hub in the country for air travel. The much awaited İzmir – Istanbul motorway is under construction and it is hoped that the new Road To The Sun will start coming in to service as early as the end of 2015. Once you are here, the

average journey time within the city is around 20 minutes and you can reach most destinations within half an hour. With the excellent port and the access to the hinterland, the increased ease in travel and the high quality of life, with its 19 Organized Industrial Zones, 2 Free Trade Zones, 7 Universities, and qualified workforce, izmir is the obvious choice for business location and investment.

Finally, İzmir and environs are the amalgamation of natural beauty and favourable weather with the abundance of cultural and historical sights. Most attractions of western Turkey are within a two hour drive and the diversity of choice for leisure is unparalleled.

Mr Grassi, tell us a little bit about your background.

I was born in Ticino and grew up there. I completed my studies in Economy and I started my career the industrial at sector, concretely in food industry. I worked at many companies as an executive manager. Over the years and until today I am focused in the consulting field and I'm the CEO of one of the most important consulting firms in Ticino. I am also part of many boards of directors at different private and public companies.

What is your impression of Turkey and the Turkish market so far?

Turkey is a dynamic market with a great capacity of growing up due to its huge internal domestic market. This capacity allows Turkey to sustain several projects abroad and increase exports

Why is Turkey interesting for Ticino?

We had 3 reasons. First of all, Turkey has a young and alive market with a great future. Secondly, there is an european mentality without being Europe (as in Switzerland) and lastly, it is a meeting point between culture and economy: Europe, Middle East and East Europe. This mix of cultures and economies creates an optimal basis for the new business.

What was the purpose of your visit?

Our purpose was to meet different SME local companies and to understand the challenges of Turkey for the next years or near future.

Also we aimed to introduce to our companies an attractive market as the Turkish one through a new channel: the business trips of the Ticino Chamber of Commerce and Industry.

The visit to Turkey allowed our companies to experience in firsthand how the country is evolving.

Which sectors are generally located in Ticino?

Ticino's main sectors and clusters:

- Banking and Financial services
- Trading
- Micro mechanics (we have a precision's pens cluster in our Canton)
- Fashion and luxury goods
- Electronics and electrical engineering
- Machine and com-ponents industry
- Logistics, trading and supply chain manage-ment
- Design and new materials
- Drugs and life sciences, chemicals

What makes Ticino so attractive for these companies?

Ticino provides a strategic location with a public support to the companies. Companies also can get scientific research support such as high quality workforce (excellent education system). Furthermore, we have a

very flexible labour market and offer advantages for trading in terms of taxation.

What does your Chamber offer for its members?

The Cc-Ti represents the interest of companies and economic associations from an institutional, political and mediatic level. We are the umbrella association of Ticino's economy.

We promote a better framework conditions for companies in our canton.

Training and consulting activities:

- Legal advice
- Advisoring in export and expedition activities
- Issue of Certificates of origin, CITES certificate, ATA Carnet and other documents
- Opening new markets: International Desk

The Cc-Ti organizes numerous courses and seminars economic, legal and political topics each year. Memories from a Swiss Education

During which time period have you gone to university in Switzerland?

I went to Switzerland at the end of 2002 for my PhD studies, following the completion of my LLM degree at Galatasaray University; and after completing my PhD at the beginning of 2006, I returned to Turkey. Thus, I have been in the Canton of Neuchâtel, Switzerland for approximately 4 years.

How come you went to Switzerland? Whose influence was behind this idea?

Before I went to Switzerland, I worked as a lawyer for some time while pursuing my LLM degree; after which, I started to work as a research assistant at the civil law department of Galatasaray University. I wanted to do my PhD abroad, especially in Switzerland since my studies were concentrated on private law. However, I cannot say that I made a special effort for doing so. When LLM was about to end, I went to Switzerland upon the invitation of Prof. Denis Miéville, one of the previous rectors of Switzerland Neuchatel University and with the encouragement of Prof. Duygun Yarsuvat, one of the previous rector of Galatasaray University.

It was a rapidly developing process, which I was not entirely ready. I can say that, it was tiring to commence my PhD studies in a foreign country, right after an intense period of LLM studies.

I should mention with gratitude, the interest and support of the honourable rector and instructors of Neuchatel University Faculty of Law, especially Prof. Pierre-Henri Bolle and Prof. Roland Ruedin and, without any doubt, my PhD instructor (Doktorvater) Prof. Thomas Probst, which they shoved me since the day I arrived in Switzerland.

Do you have any special memories?

As known, Switzerland is a place which is famous for its trains' punctual arrival, in so much that I heard about such punctuality before going to Switzerland. Indeed, I have witnessed such punctuality over the years; however, it is natural to encounter disruptions in situations where the human element and machines are involved. Within the first hours of my setting foot in Switzerland, I came across with such a disruption, with a significant delay in train schedules, and it was a surprise for me. Seeing over the years how punctually arriving the trains are, such rare situations are not even remembered, for sure.

Please give us a brief insight on your personal experiences during that time.

In fact, PhD studies are a tough and maybe a little abrasive experience, regardless of where it is done. When it is in a foreign language in a foreign country, difficulties naturally are increasing a little bit more. However, besides the difficulty, I should say that it was extremely enriching, enlightening and a great experience in academic sense.

Although I have completed my PhD studies in Canton of Neuchâtel, Switzerland where French is spoken; French is not sufficient by itself to pursue a PhD in law in Switzerland. One should speak German too. I spoke French when I went to Switzerland, but my German was not at a sufficient level. Therefore, I had to improve my German while I was doing my PhD. This, of course, required a quite intensive work. I've been in Germany for a while too.

I should say that it was also very efficient process in terms of facilitating new friendships and broadening my network, and the contribution of the academic environment was extensive and notable either.

Describe briefly the Swiss education system in comparison to the Turkish one.

I can easily say that, Switzerland is more advanced in education; at least in terms of infrastructure. Undoubtedly, the relatively small population and the income level are the main factors effectuating such result. The most important difference between Turkey and Switzerland is that; in Switzerland, starting from primary and secondary school, children are guided towards different areas according to their personal characteristics. It can be said that, Switzerland is <u>quite</u> successful in education.

What is so special about Swiss education? What do you appreciate most having studied in Switzerland?

My acquaintance with the Swiss education system is limited to my PhD studies. Therefore, I cannot comment on all the features of the Swiss education system; since PhD studies do not reflect a nation's entire education system. However, if I were to limit my evaluation to PhD studies; I can say that, all kinds of facilities and amenities are provided to PhD students in Switzerland; and that is for sure, a very important feature.

What would you recommend Turkish parents who want to send their children to a Swiss boarding school?

I can genuinely recommend Switzerland to Turkish parents. By spending a part of their education lives in a foreign country, especially in Switzerland, their children will gain a deeper perspective, a broader network, increase their cultural and intellectual wealth. Such an experience will contribute substantively to their personal globalization process.

TOWARDS A MORE LIBERAL TURKISH ENERGY MARKET: THE NEW PETROLEUM LAW

Turkey's importance in world energy markets as both a regional energy hub and a growing consumer has been growing over the past few years. While the country's energy use is still relatively low, it is nonetheless increasing at a fast pace. In general, the country has been enjoying a steady rate of growth for the past decade, which has created a strong economy but also significantly increased the demand for energy. The state itself cannot meet this level of growth and therefore needs to obtain the support of the private sector in order to complete large investments in energy production and infrastructure. The primary aim and vision of the Turkish government for the next decade is to reduce the country's heavy reliance on imported energy and advance toward energy self-sufficiency. This is intended to be achieved through increasing domestic supply of oil and gas as well as diversifying domestic energy supplies, which entails greater use of nuclear and renewable energy resources.

Turkey is not an oil-rich country and imports nearly all of its oil supplies. Historically, the right to explore and produce petroleum has either been exclusively owned or managed by the Turkish state. The ability of the private sector to operate in the sector was limited by insufficient legislative framework, bureaucratic obstacles and also barriers on foreign investment. Also, since its incorporation in 1941 the state-owned Turkish Petroleum Corporation (TPAO) has enjoyed either a monopoly or preferential rights which made market entry very difficult, if not impossible, for private investors and thus prevented the establishment of a competitive petroleum market.

This has started to change with the recent legislative reforms in the energy market and the new Turkish Petroleum Law No. 6491, which officially passed into legislation on 11 June 2013, is among them. Overall, the new Petroleum Law aims to minimise bureaucracy; provide incentives for exploration and production operations; reduce the costs of operations and create a more competitive environment. What is of particular importance for foreign investors is that the Law removed the restriction existing under the previous Law, which limited the person(s) acting for and on behalf of a foreign state from engaging in petroleum activities in Turkey. Furthermore, the Law provides incentives for investors some of which are aimed specifically at foreign investors. For instance, there are tax-related incentives (including a cap on income tax deductions applicable to investors and exemptions from customs duty, levies and stamp tax for oil and gas equipment imported and supplied locally), ability to employ foreign staff for a period of six months without having to obtain a work permit, removal of barriers on repatriation of capital, the right to keep abroad the foreign currency generated from the exportation of petroleum, expropriation and lease of land and so on. The new Law has also simplified the obligations regime and now only includes administrative sanctions applicable for violations of the obligations set forth by the Law.

As well as the incentives the new Law also allows for exploration and operation licenses to be granted and extended for longer periods. Thus it provides the investors with sufficient time to conduct their activities. The responsible authority for granting licenses under the new Law is the General Directorate of Petroleum Affairs, which allows the investors to compete on equal terms with the TPAO, who was authorised to issue licenses under the previous regime.

The provisional articles of the new Law provides that new exploration licenses may not be obtained for a year following the publication of the Law. As seen above, the Law was published on 11 June 2013 and therefore this deadline has now expired. The implementation directive of the Law, which was enacted in January of this year, provides the procedures concerning new applications as well as the adjustment of the existing licenses with the new Law. Therefore the existing and prospective investors are able to submit new applications, adjust their existing licenses and be informed about the fine details of the relevant procedures.

To sum up, the new Petroleum Law is a right move towards the liberalisation of the petroleum market. That said, it could still do with some improvements especially in terms of offering a more flexible and varied licensing regime for the benefit of small investors and startup companies.

"Der Chor" from Lucerne revived on the 31st May this journey in two ways: on the one hand, by bringing together music from the Orient and the Occident and, at the same time, by making the journey to Istanbul itself and by giving a concert here in the venerable, disused halls of the railway station Haydarpasa. The concert was supported by the Consulate General of Switzerland.

Der Chor Luzern performs works which embody the Western roots of choral music. They include musical interpretations of literature, which has been set to music repeatedly throughout the western world from Istanbul, formerly known as Constantinople, to England. 
Young Performance Artists Festival

Immigration vote: businesses fear lack of skilled workers

Swiss business leaders have criticised the government for not using all the time at its disposal to implement the result of a national referendum, two days after the proposal of a draft law on immigration curbs. In response, the government urged companies to make more of an effort.

In February, 50.3% of Swiss voters approved a proposal by the rightwing Swiss People's Party to reintroduce immigration quotas for EU citizens, as well as a national preference when filling job vacancies. It also stipulates that Switzerland will have to renegotiate its bilateral accord with the EU on the free movement of people within three years or revoke it.

The cabinet, which had urged voters to reject the proposal, suddenly found itself with three years to implement a result which violates a fundamental element of the EU: the freedom of movement for all its citizens. Switzerland is not part of the EU but has signed various bilateral agreements with the 28-nation bloc, including on free movement of labour, partly to ensure its access to European markets.

The government is aware that it will upset someone whatever it does. "You can twist and turn as you like, the new models are either unconstitutional or not compatible [with EU agreements]," Justice Minister Simonetta Sommaruga admitted on Friday. The government said the new law would set immigration quotas — as voters demanded in February — but hoped softer rules for EU citizens may reduce retaliatory measures from Brussels and big neighbours such as Germany and France.

It did not specify exactly what restrictions the new law would impose on EU citizens. The government said it had refrained from setting a fixed, inflexible target for reducing immigration in its proposal for the law, which will come into force in 2017.

As expected, the European Commission swiftly denounced the Swiss proposal as "irreconcilable" with a pact that since 2002 has allowed Swiss and EU citizens to cross the border freely and work on either side as long as they have a contract or are self-employed.

"Quantitative limits and national preference are contrary to our treaties. Negotiating them is not an option for the Commission," Commission spokeswoman Maja Kocijancic said.

Business leaders fear that immigration quotas will make it harder – if not impossible – for them to attract the necessary skilled employees. In addition, they believe picking a fight with the EU on this issue will make already tough negotiations even tougher. "Without specialists from abroad, we'd have to move part of the work abroad," warned Hans Hess, president of the Swissmem industrial lobby group, in the NZZ am Sonntag.

Heinz Karrer, president of economiesuisse, the Swiss Business Federation, told the Zentralschweiz am Sonntag that he feared "a negative impact on Switzerland as a business location" if highly skilled workers could be recruited only in reduced numbers. For his part, Economics Minister Johann Schneider-Ammann defended the government's proposal — as he is obliged to by the principle of collegiality — saying "all sides have their jobs to do and must deliver".
